### SCAF 2009 RULES AND REGULATIONS

1. Artists may begin setup on Friday. Exact time will be specified in acceptance packet. Assigned space will be forfeited if artist is not present by 8:30 am on Saturday.
2. Artists must set up booth display and be open by 9:00 am Saturday and 10:00 am on Sunday and remain open until 5 pm on both days.
3. All artists accepted into the SCAF must personally exhibit their work. All named artists will be asked for photo ID during roll call.
4. Artists must prominently display the booth card provided by SCAF identifying the artist's name, space #, category, and residence (city and state).
5. All artists must exhibit original work and no ribbons or awards from other art shows or gallery cards may be displayed. Any winning art work from a previous SCAF that is displayed is not eligible for cash awards and must be clearly marked "NOT ELIGIBLE FOR JUDGING."
6. Art work to be judged must be framed or prominently displayed with selling price or marked "Not for Sale". Other unframed work may be displayed in a portfolio or bin.
7. All art work submitted for judging must be the artist's original work. Limited edition prints are not eligible for judging/awards.
8. Photographs must be the artists' original work and should be signed.
9. Each exhibitor is responsible for the collection of Florida sales (6%) made during the festival. Send sales tax to: State of Florida, Dept of Revenue, Tallahassee, FL 32304. Tax forms will be provided in artist's packet.
10. One booth space is assigned per entrant and location preference will be given to returning artists when possible. Exhibitor's belongings must be contained within that 12' X 12' space and no pets are allowed, except for service dogs. Artists' booth may not be attached to pavement or other structures. No changes in booth space may be made without the express approval of the Registration Chairperson. No generators allowed.
11. Four digital images must be submitted with application (unless artist received an award in last year's show). Three images must represent the work to be displayed and a fourth must show the entire display booth. You may submit your images on CD or DVD-ROM disc in jpg format and individual image size must be 5 Mb or greater and should carry the camera's original file number or tag. Artist's name must be written on disc. Or alternately, you may submit four slides, clearly indicating the top of the slide and the artist's name. No print photographs will be accepted.
12. A jury comprised of art professionals will preview all submitted art and select the entrants. Only a letter and a number will identify the artist's work.
13. Items NOT permitted in SCAF: all buy/sell; jewelry not totally handmade, including settings; ceramics cast from commercial molds; crocheted or knitted items; string art; candles; decoupage; china painting; shell craft; any item made from kits or mass produced; commercial displays of picture frames, art supplies, loose stones, belt buckles, etc.
14. Artists not in compliance with the rules and regulations of SCAF will be ineligible for cash awards and admission to future festivals. "No-Shows" or exhibitors leaving before the close of the festival will not be invited back. SCAF reserves the right to refuse any application.
15. A paid registration is a commitment to SCAF and there will be NO REFUNDS. If you are not accepted through the jury process, your entry fee of \$250 will be refunded and your disc or slides returned only if you provide SASE of sufficient size and postage.

### SHOW TIMES, DATES, & REQUIREMENTS

Saturday November 28, 2009 - 9:00 to 5:00 and Sunday, November 29, 2009 - 10:00 to 5:00

1. Deadline for submission of valid application is August 1, 2009
2. A valid application **must** include the following: **\$250** entry fee plus a **\$25** jury fee for each category entered plus 4 digital images on CD or 4 slides (3 of work, 1 of booth display), and a SASE. (*Returning winners of category/merit awards of SCAF 2008 are not required to send discs or slides if entering in same category.*)
3. Mail application including discs or slides, SASE, and **one** check made payable to **SCAF** to: SCAF Inc. Registration Chairman, P.O. Box 320135, Cocoa Beach, FL 32932-0135
4. Discs or slides will not be returned if SASE is not of sufficient size and postage.
5. Acceptance notification will be mailed to artist by mid-September 2009.
